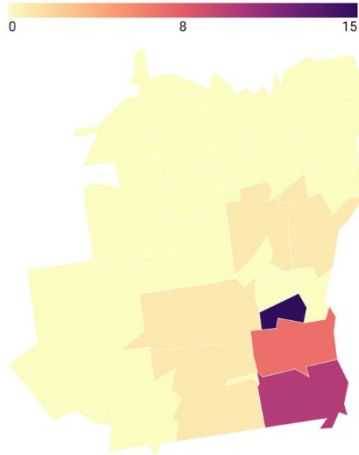

Data from 01/01/2017 - 08/29/2023

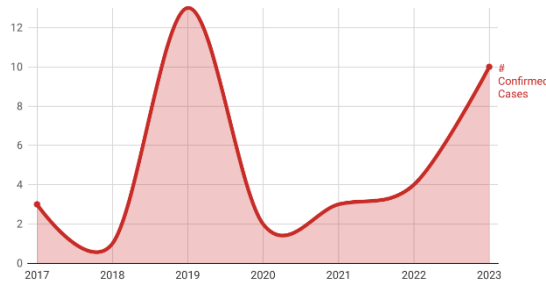

Positive specimens represent only a fraction of the animals submitted for rabies testing.

To date in 2023, ECHD (and our partner veterinary clinics) and the NYS DEC have submitted over 60 animals to Wadsworth Laboratory for rabies testing, including fox, skunks, bats, raccoons, woodchucks, and other mammals.

We must comply with NYS Public Health Law and other NYS codes, rules, and regulations.

As such, **ECHD is required to conduct activities and services with respect to rabies including:**

- Follow up of potential exposure of persons to rabies;
- Follow up of potential exposure of domestic animals to rabies, including the investigation of incidents involving domestic animals exposed to or potentially exposed to rabies;
- Providing authorization for rabies post-exposure prophylaxis (RPEP), when indicated, and following up to ensure reimbursement for treatment for exposures that occur in Essex County;
- Reporting of all RPEP related to exposure in the county and creation of a case investigation for all instances where an animal is confirmed rabid by Wadsworth Lab;
- Rabies surveillance, prevention and control activities, including organizing and conducting pet vaccination clinics at least once every four months; and
- Rabies education and outreach, including public awareness campaigns to prevent animal bites and bat encounters and distribution of materials.



ECHD is not allowed to conduct the following rabies related services or provide reimbursement for the following:

- Expenses for wound care or other medical treatment outside of RPEP;
- *Nuisance animal control, such as stray dog and feral cat abatement and removal of wildlife from domestic property in the absence of a potential rabies exposure;*
- Boarding and other expenses to maintain and house an animal during confinement;
- Pre-exposure rabies vaccinations and subsequent serum sample collection and submission;
- Law enforcement related expenses other than for enforcement of 6-month quarantine and 10-day confinement; and
- Disposal of animal remains not confirmed to have rabies.

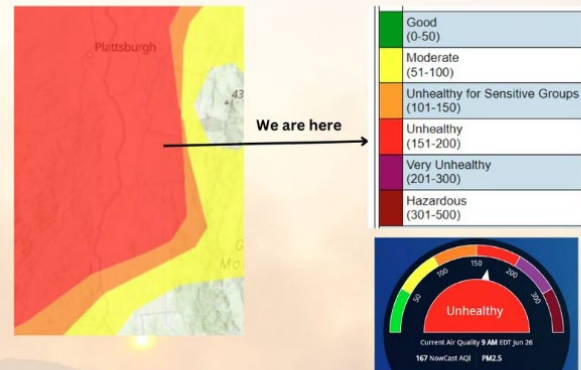

Unhealthy (151-200) People with heart or lung disease, older adults, children and teens – take any of these steps to reduce your exposure:
