### Annual Report Revitalization

New report under final review as a Pandemic Response Report for 2020-2022 and includes the 2019 (pre-pandemic) Department activities.

### Community Health Assessment & Planning

- NYSDOH Prevention Agenda may shift to Healthy People 2030
- Ongoing meetings through coalitions, Networks, Meetings to keep on track with all goals & objectives of the last CHIP.
- CHA/CHIP due December 2024 & goal is to include updates on CHIP from previous cycle.

### Communicable Disease Prevention

#### Immunization Program Audit

- Only 1 issue was found during the NYSDOH/CDC program audit.
  - It was requested that on all open/operating days, the vaccine fridge and freezer be physically documented as current (2x/day) and min/max (1x/day). Correction noted & submitted back to DOH for review/approval.
- Due to loss of 2 trained staff, new staff identified & trained. Additional job aids were created so new staff performing this function can most easily reference & maintain this capacity.

### Enteric Illness Disease Investigations & Outbreak Planning

- Last quarter 3 staff attended a regional meeting re: Foodborne Illness Complaints/Reports.
- This quarter 2 staff attended an in-person 1-day training on disease outbreak response.
  - Summer months create incredible influx of potential outbreaks.

## Sexual & Reproductive Health

- Initiating a contract with the Planned Parenthood of Greater NY to allow Essex County residents to seek access thru Planned Parenthood closest to them.
- HIV Testing revitalized
- HCV Testing revitalized

## Rabies 2024

- Significant concern and effort into situation in Westport with swine livestock that had exposure to confirmed positive skunk.
- To date 24 animals submitted for testing; 5 positive.
  - 2<sup>nd</sup> Rabies + raccoon MORIAH; 3122 Broad St., Port Henry
  - 1st rabies + raccoon. ELIZABETHTOWN; New Russia.
  - 1st rabies + woodchuck. MORIAH. College St; Port Henry.
  - 2nd rabies + skunk. WESTPORT. 5841 NYS Route 9N.
  - 1st rabies + skunk. WESTPORT. Stevenson Rd (corner of Mtn Spring Rd)

- Although not a confirmed Rabies Case, we wanted to provide an update regarding three separate events that occurred over the Memorial Day weekend - all in the town of WESTPORT. See attached map for approximate incident locations - labeled Fox Attack #1, #2, #3.

### • Saturday - 05/25/2024

- Incident #1: A fox attacked a resident while they were out gardening and then ran off. Main St, WESTPORT

### • Sunday - 05/26/2024

- Incident #2: A fox attacked a young child while they were on their porch. Fox displayed unusually aggressive behavior. Despite significant attempts to locate the fox, residents at this location were unsuccessful in finding the animal. Main St, WESTPORT
- Incident #3: A fox attacked a person while they were outside in their yard - again, fox ran off. (*Note: ECHD was not notified of this incident until 05/28/2024*). Ledge Hill Rd, WESTPORT



- 7 Clinics schedule for 2024 increasing access to new locations.
  - March – Westport - 67
  - April – Jay - 76
  - May – Moriah 146
    - Moriah was 146; largest since Moriah 2021; 157.
    - July, August, October scheduled.
- Rabies Profile 2024 created to share with multiple audiences
- Will present at upcoming NYS Ag & Markets training with Animal/Dog Control Officers to improve shared understanding & roles/responsibilities.

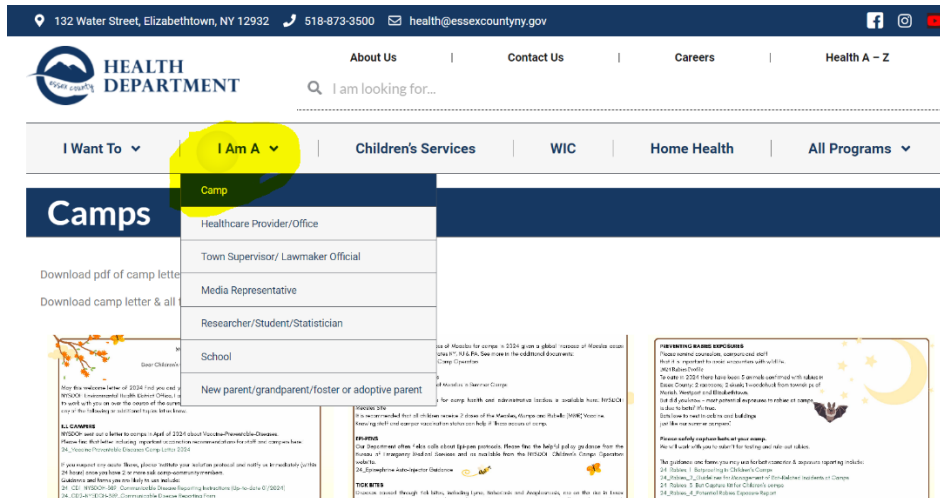

- Working with Essex County DPW, Planning, Town of Willsboro, Town of Lewis and NYSDOT to conduct the CDC's Active Communities Tool (ACT) assessing community readiness to support Active Living by Design
- Next step is to request funds (through NYSDOT) to conduct General Route 9 Corridor Study and Willsboro Active Transportation Linkage Study
- Then Essex County will be better able to apply for Transportation Assistance Program (TAP) funds from the NYSDOT.

- Gathering of all grant-funded partners and District Office to champion tobacco prevention & control.

## Family Health

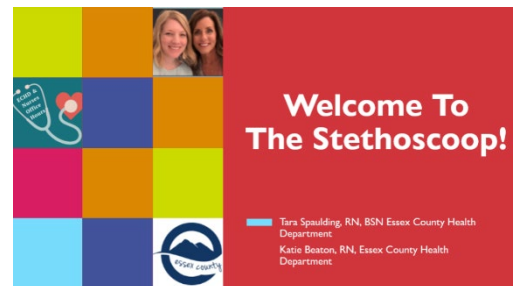
### Baby Steps to Bright Futures –

### Car Seats

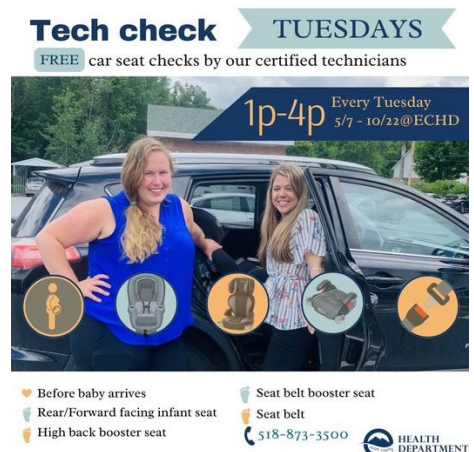
- Grant for Oct 24 – Sept 25 submitted.

- 1 new staff person identified to cross train to deepen this capacity.



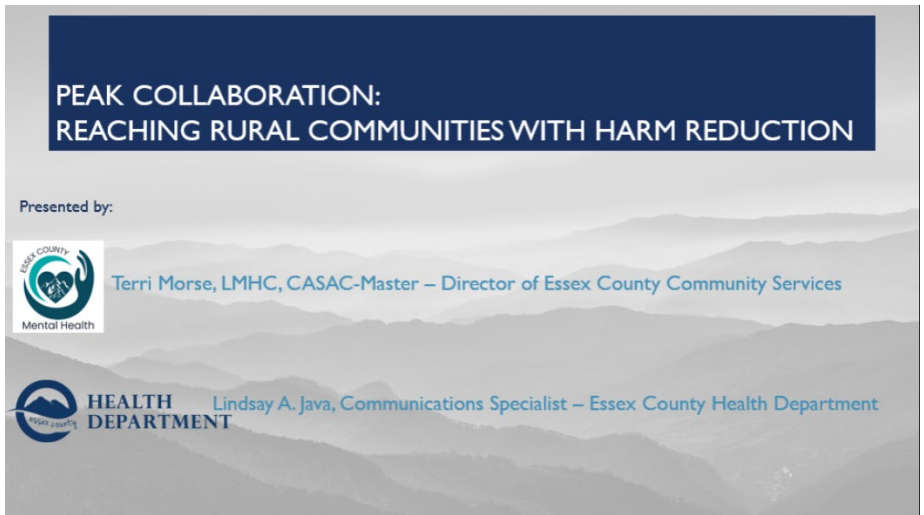
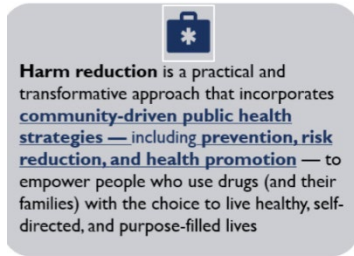
