DIRECTOR HIGHLIGHTS



I recently had the privilege of attending the NACCHO 360 Conference in Detroit, Michigan; it was a transformative experience for me as a Public Health Director in Essex County in addition to my role as NYSACHO President for New York State. NACCHO 360, organized by the National Association of County and City Health Officials, is a premier public health conference that brings together professionals from across the country to share knowledge, innovations, and best practices. This year's conference offered an array of in-depth trainings, workshops, and sessions focused on emerging public health issues, leadership, and community engagement. Each session provided valuable insights that I am eager to apply in my role to enhance the health and well-being of our community.

The comprehensive trainings I attended were instrumental in broadening my understanding of current public health challenges and solutions. Topics ranged from innovative approaches to combating infectious diseases to strategies for improving mental health services and addressing social determinants of health. One particularly impactful session was on leveraging data analytics to drive public health decisions, which highlighted the importance of data-driven strategies in creating effective health programs. These learnings are crucial as I continue to develop and refine programs in Essex County, ensuring they are both effective and responsive to the needs of our residents.

As the Public Health Director, my goal is to lead with informed and proactive strategies. Essex County is a region with unique health challenges, from its rural landscape to its diverse population. The knowledge gained from NACCHO 360 equips me with the tools and insights needed to address these challenges effectively. By integrating the latest public health practices and collaborative approaches learned at the conference, I am confident that our health department can continue to provide exemplary services and improve the health outcomes of our community. The conference not only enhanced my professional growth but also reinforced my commitment to advancing public health in Essex County.

Health Department Highlights

STAFF TURNOVER – UPDATE

Search is ongoing to fill the two (2) vacant nursing positions in Public Health. We have expanded advertising and promotion of these positions.

ACTIVE COMMUNITY EFFORTS UNDERWAY

Our Chronic Disease Outreach Coordinator is championing several projects related to complete streets and active community design, including:

- Coordinating a meeting with the NYS Department of Transportation and Essex County Department of Public Works to discuss the disbursement of funds (\$100,000) and planning process for corridor studies in the towns of Lewis and Willsboro. RFPs have been drafted and are under review.



- Participating in a Community Walking Assessment in the Town of Westport. Representatives from the NYS Governor's Traffic Safety Committee, the NYS Department of Transportation, the Town of Westport Safe Roads Committee, the Essex County Sheriff, Westport Town Council, the New York State Police, the Adirondack Park Agency, and Essex County Department of Public Works also participated.
- Ensuring completion of an Active Community Plan for the Town of Lewis and submission to the New York State Health Department, successfully meeting the eligibility requirements for Local Health Department Performance Incentive Funding. The Essex County Department of Health received confirmation from the New York State Health Department that it is additionally eligible for a "bonus award" from the Performance Incentive Funding due to submitting more than the required two modules.

ECHD SUMMER ROADSHOW

WIC CONNECTS LOCAL PEOPLE TO LOCAL FOOD

This summer WIC is working with The Essex Food Hub through a grant. To date this year, we have successfully distributed to 93 Essex County WIC families more than \$4K worth of local meat, yogurt, oats, and produce through our boxes, and distributed to more than 120 families, \$2K in local meat, yogurt, and produce through bulk donations. Some of the bulk foods distributed are pictured in the newsletter attached. Families receiving boxes are located in; Schroon Lake, North Hudson, Newcomb, Minerva, Bloomingdale, Westport, Saranac Lake, Lake Placid, Keene, Crown Point, Moriah, Port Henry, Wilmington, Elizabethtown, Ausable Forks, Keeseville, Willsboro and Ticonderoga.

The feedback has been great:

One family said, "I'm making frozen yogurt with the yogurt you sent us! And the beef! Wow! Thank you!"

Another family said, "You are really helping us stretch our food dollars. We are now able eat healthier as a family!"

The boxes will continue to be distributed every other week for the next 9 months.

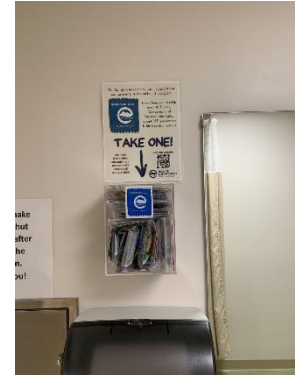

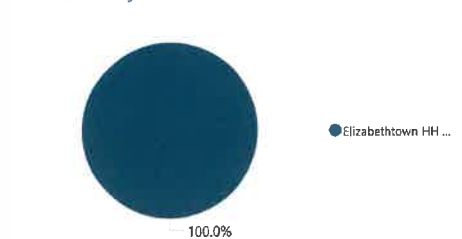

Admissions by Type & Business Unit*

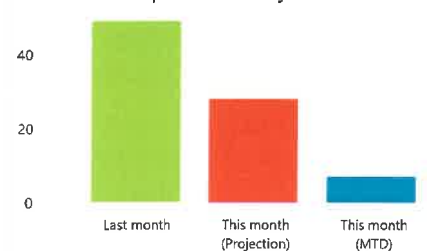

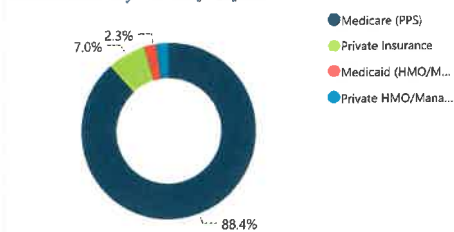
Admissions by Business Unit*



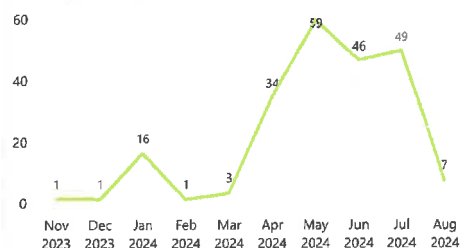
Admission Comparisons & Projections



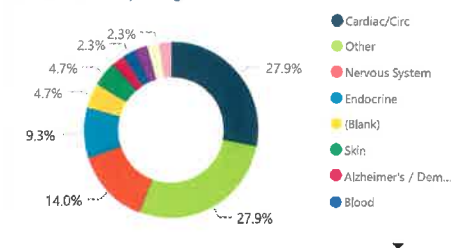
Admissions by Primary Payor*

Admissions by Diagnosis*

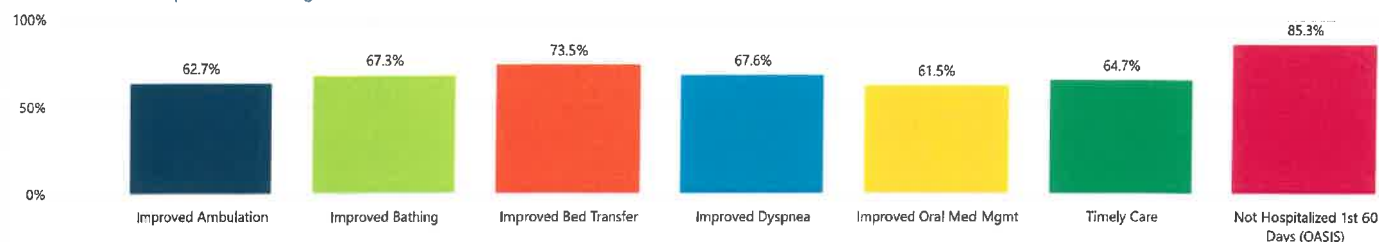

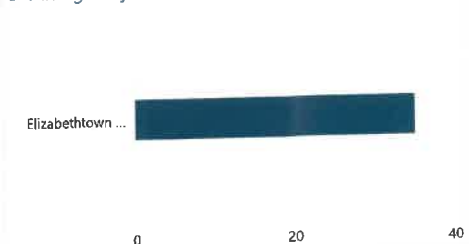
Home Health Compare Star Rating Measures



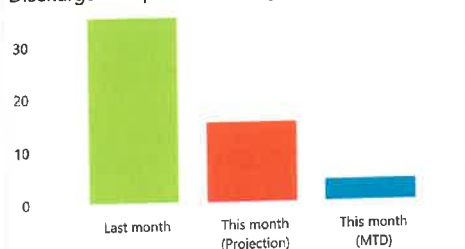

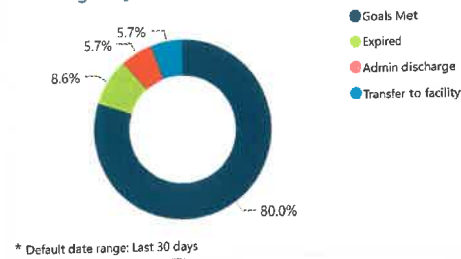
Discharges by Business Unit*



Discharge Comparisons & Projections

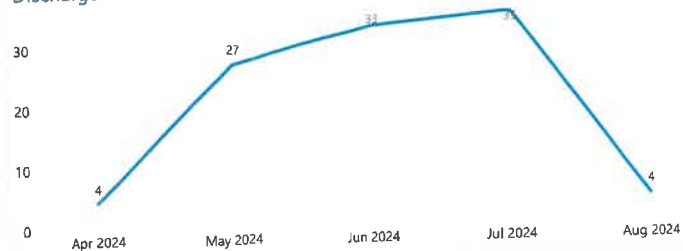


Discharges by Reason*



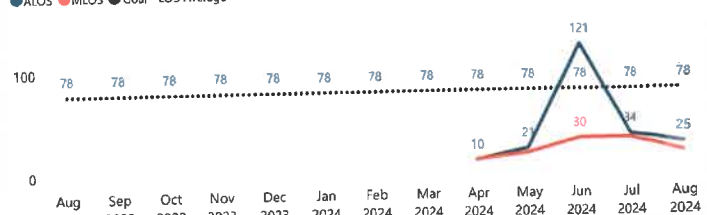
