*Essex County Public Health Director elected NYSACHO President*

**Elizabethtown, N.Y.-** Essex County Health Department announces New York State Association of County Health Officials (NYSACHO) results of its 2024 election for Board of Directors. Public Health Director, Linda L. Beers was appointed President. During NYSACHO's annual meeting, Heidi Bond, Public Health Director of Otsego County, was also elected by the membership as Vice-President.

NYSACHO supports, advocates for, and empowers local health departments in their work to promote health and wellness and prevent disease, disability and injury throughout New York State. NYSACHO represents all 58 local health commissioners and public health directors, serving as the voice for all of New York State's local health departments. The organization keeps health services a priority in New York State's budget decisions and supports media outreach for public education.

Appointed Public Health Director for the Essex County Health Department in 2010, Linda Beers guides public health, early child development, and home health professionals, she champions equitable access to healthcare for all in Essex County. Her two-pronged approach tackles disparities rural communities face head-on: advocating for increased service availability and developing programs that bring care directly to residents. This unwavering commitment aligns perfectly with her expertise, education, and deep connection to the community.
