Federal and state partners are engaging local health departments on preparedness for the spread of H5N1, also known as HPAI or Highly Pathogenic Avian Influenza. The initial advisory regarding a H5N1 case in a human occurred in April of 2024. Since then there have been no positive test of dairy cattle or humans in New York, nor has there been documented human-to-human transmission anywhere in the US. While the CDC considers the risk of H5N1 viruses to humans to be low, LHDs across the state are planning for what could happen, if and when H5N1 cases occur in New York.

NYSDOH considers LHDs to be vital partners in planning for potential scenarios and responding to real life scenarios. Our Department is staying current with ongoing federal and state updates, and working to be prepared for responses such as collaborating with CCE and local farmers; providing guidance on PPE; supporting specimen submission; planning for season influenza vaccines; conducting contact tracing and symptom monitoring to those exposed and supporting wrap around support for people who may need to isolate.

#### STAFF TURNOVER – UPDATE

The Public Health Unit lost two nurses at the end of May and has not received any applications. A Principal Account Clerk will start in July.

#### CAMP SEASON OUTREACH

In-person training for municipal camps (9) was provided in collaboration with the Youth Bureau and connection was made with 85-100 summer camp staff. Major areas of content include ill campers (communicable diseases); Air Quality, Harmful Algae Blooms (Blue-Green Algae) and rabies.



#### HELMET FITTING EVENTS

The Essex County Health Department in collaboration with Safe Kids Adirondack purchased, fitted, and distributed over 630 bike helmets to Ticonderoga, Crown Point, Moriah, CVES Mineville schools, and Essex County Head Start – PreK – 1<sup>st</sup> Grade Students!

The Department continues to network with town supervisors, local programs and DSS on improving situational awareness, bridging connections and ensuring the health and safety of refugees/migrants as they enter Essex County.



\*In a recent survey of 88 WIC participants, 88 WIC participants struggled to afford protein foods, and fruits and vegetables weekly. Eighteen out 88 stated they did not have basic tools (cutting board, knives, can opener, etc.) to prepare food at home.

The WIC-n-Pick program is bringing families to two local farms again this summer. We love showing families where their food comes from and how to use it. Through a mini-grant from Rotary Club of the Adirondacks, WIC is able to purchase cooking utensils, show participants how to use them, and share simple, healthy recipes.

Families go home with all the produce from each farm. The pictures shown below are from our first week at Craigardan-WICGardan. WIC families have their own garden at Craigardan this summer.

Everything was planted with the help of WIC kids. Families can go to Craigardan throughout the summer and weed, water, and harvest anything from the WICgarden. We would love you to come out to any of our sessions!
